- B. Cranbury School Representative DJones reported that 1) school board election now final with two write-in candidates as new board members and herself reelected, 2) annual Lions Club Holiday Breakfast will be held on school property this year as it was cancelled last year due to COVID, 3) two vaccine clinics were held at the School with 153 2nd pediatric doses and 98 adult boosters administered, and 4) NPetrone, School Business Administrator, has resigned and her replacement. David Weidel has been announced.
- C. Foundation Report: PThomsson no report but did comment that the donor wall and brick program will be taken up in January. There is also not likely to be any overt fundraising in 2022 but may resume in 2023.

- A. Budget Presentation –2022 Budget detail was presented by MMullen and she offered sound explanations for each budgeted amount. While concern was raised about sufficient funds allocated for new library launch, MMUllen noted she has accounted for these anticipated expenses in several budget categories. - B. Paid Holidays for Staff MMullen presented exhibits outlining the minimal costs for two additional paid holidays for full- and part-time staff. Noted, too, that Cranbury Township gives 10 days (versus 8 for Cranbury Library) and that most local libraries offer more than 8 paid holidays. Motion to approve granting of two additional paid holidays, one to be Juneteenth and the other a floating personal day, made by DCarroll, second PThomsson. ROLL CALL KV, DF, PT, DJ, DC, MF vote yea, IN abstention, none opposed, vote carries with six yeas.
